

Application Guidelines for On-Campus Dormitories (September 2026 Entry)

*Exchange students staying for One-term and Full-year are not eligible. Please refer to separate instructions.

1. Eligibility

This application is open to the following students:

1) September 2026 New Students

- Undergraduate students (including transfer students)
- Graduate students (the 5-Year Program, Master's Course, and Doctoral Course)

2) Current ICU Students (Mid-year Applicants)

- Undergraduate students currently enrolled at ICU
- Graduate students currently enrolled at ICU

2. Important Notes Before Applying

To apply for on-campus housing, please carefully read this document and the information available on the Housing Office website: <https://office.icu.ac.jp/ho/en/>

1) Application and Selection

- Applications are screened based on the submitted information.
- **Due to limited capacity, not all applicants will be admitted.**
- Late applications will NOT be accepted.
- Any inquiries regarding the selection results will not be accepted.
- Applicants receiving housing-related scholarships must still apply within the designated period.
- If not admitted, applicants must arrange housing independently.

2) Others

Additional Notes for Undergraduate Dormitory

- Bathrooms, kitchens, living rooms, and other facilities are shared within each dormitory or floor.
- In Global House, the first and second floors are designated for male residents, while the third and fourth floor are designated for female residents.
- In Zelkova, Ginkgo, and Oak House, the first floor is designated for male residents, while the second and third floors are designated for female residents.
- In Momi and Maple House (2nd–5th floors), the second floor is designated for male residents, while the third to fifth floors are designated for female residents.
- The 6th floor of Momi House is a co-ed floor (male and female residents).
- **Most dormitory rooms are double-occupancy rooms. Single rooms are limited and are restricted by dormitory, floor, or academic year.**
- **Requests for single rooms cannot always be accommodated. Applicants who require a private room should also consider off-campus housing.**

Additional Notes for Global House Tutors

- Only those who have selected Global House Tutors as their first-choice residence will be considered for selection.
- Tutors will live in the same dormitory as undergraduate students and are expected to serve as advisors for dormitory life.
- Tutors are also expected to hold office hours approximately twice a week and submit one report per term.

- If you wish to become a tutor, please describe how you can contribute to undergraduate dormitory life in the application form.

- Applicants who pass the screening process will be invited to an interview at a later date. The interview schedule will be communicated individually after the application form has been submitted.

- If you do not receive the automatic reply message, your application may not have been successfully submitted due to an incorrect email address or other error. In that case, please contact the Housing Office.

8. Notes on Completing the Application Form

1) Your Family Information

- Under family members, fill in all members up to second-degree relatives, including those who are independent or living separately. For grandparents, include only those who live with you.
- If you have siblings who are currently in school, please indicate the type of school they attend and their current grade.

2) Household Income

Please fill in the annual income column by referring to the following documents:

- Withholding tax slip issued by your employer: "Amount Paid"
- Income certificate issued by a municipal office: "Total Income (Salary Income)"
- Tax return form: "Total Income Amount"

You may be asked to submit supporting documents such as a withholding tax slip if necessary.

9. Screening of Dormitory Residency

As the number of applicants typically exceeds the number of available spaces, not all applicants can be admitted.

Selection will be conducted based on a comprehensive review of the information provided in the application, including reasons for applying, family composition, and household income.

Applicants are expected to understand the philosophy of ICU dormitories and demonstrate a willingness to actively participate in dormitory life.

10. Medical Examination

All residents are required to undergo the annual medical examination conducted by the university each April.

The medical examination is regulated by the School Health and Safety Act and it is an important opportunity to support students' health and well-being during dormitory life.

Failure to take the examination may result in the cancellation of dormitory residency.

11. Vaccination

Before moving into the dormitory, please confirm your vaccination history for the following diseases:

- Measles
- Rubella
- Mumps
- Varicella (chickenpox)

If you have not received two doses for each vaccine, please obtain additional vaccinations at a medical institution so that you have received a total of two doses.

Vaccination is essential in dormitory life to prevent infectious diseases.

Please take responsibility for protecting your own health and preventing the spread of infections on campus.

- ICU considers completion of these vaccinations as a basic requirement for communal living.
- These diseases are designated as "infectious diseases to be prevented at school" under the School Health and Safety Act.
- Students who contract them are prohibited from attending classes until cleared by a doctor.
- Submission of vaccination certificates is not required; however, each student is responsible for confirming their own vaccination history.
- If you are unsure about your vaccination history, number of doses, or antibody status, please consult a medical institution.

12. Common Rules and General Matters

1) Period of Residency

- a) CLA Regular students: up to four years after enrollment
- b) CLA Transfer students: up to three years after enrollment
- c) CLA One Year Regular students: up to 10 months after enrollment
- d) Graduate students in Master's Course: up to two years after enrollment
- e) Graduate students in the 5-Year program of Master's Course: up to one year after enrollment
- f) Graduate students in Doctoral Course: up to three years after enrollment

*Even if a student's graduation date is extended due to a leave of absence or other reasons, the dormitory stay period will not be extended.

2) Cancellation of Qualifications for Residency

The Dean of Students may cancel the qualifications for residing in the dormitory for either of the following reasons.

- a) If false statements were found to have been made on the application for entrance.
- b) If dormitory fees are not paid.
- c) If registration for classes is not made.
- d) If a student violates university regulations or significantly disrupts dormitory management or community

3) Dormitory Open Period and Summer Closing

The annual residency period for student dormitories is ten months and is determined based on the University's academic calendar. During the summer recess (approximately two months in July and August), the dormitories are, in principle, closed due to university programs and dormitory maintenance or renovation work. Students are required to vacate the dormitories during this period.

4) Moving out of the Dormitory

- a) Specified due date for moving out
 - Spring Term: Late June
 - Autumn Term: Late November
 - Winter Term: Designated move-out date in March
- b) Residents who take a leave of absence or withdraw from ICU or study abroad are to move out of the dormitory.
- c) Those who are moving out of the dormitory before the term expiration must submit the "Application for Withdrawal from the Dormitory" to the Housing office, no later than one month prior to the intended date of withdrawal. Even if you move out in the middle of the term due to unavoidable circumstances, or if you are required to vacate as a result of a move-out recommendation as disciplinary action, any dormitory fees already paid will not be refunded.

5) Returning to the dormitory

As a basic rule, students participating in ICU's exchange programs or Accredited Privately Financed Ryugaku can return to the dormitory by submitting the following documents. (Excluding those on leave of absence or studying abroad without ICU's approval.)

- a) Application for withdrawal from Dormitory
- b) Application for Returning to Dormitory

6) Dormitory Entrance Fee and Dormitory Fees

- a) Upon your entry to the dormitories, the dormitory entrance fee must be paid together with the dormitory fee.
- b) Dormitory entrance fees and dormitory fees may be revised every April.
- c) The dormitory fee will be charged from April 2026. Dormitory fees must be paid in full, per term, in Japanese yen. The first (spring) and second (autumn) terms must be paid for three months each, and the third (winter) term must be paid for four months in a lump sum.
- d) For the dormitory entrance fee and dormitory fees, please use the university's prescribed payment form to be provided after moving into the dormitory, and make payment at the Yucho bank. Please also transfer the dormitory

fee from the post office in the same way, using the payment slip, for the following term for subsequent terms in the same manner using the payment slip.

- e) If you wish to make an overseas remittance, the necessary information will be provided when the payment slips for domestic transfers are distributed.

*Each dormitory collects a small amount of money to purchase items for shared use.

*Any entrance fee or dormitory fees you have paid will not be refunded to you, regardless of your reason for moving out from the dormitory.

7) Dormitory Supervisors

There are live-in dormitory supervisors to oversee the dormitory's management and operations as well as the mental and physical well-being of its residents. They live on campus to cope with emergency situations.

There are residences for supervisors on the first floor of the Fourth Women's Dormitory and Zelkova, Ginkgo, Oak and Momi/Maple House.

8) Meals

Meals are not provided, but dormitory residents may use the University Cafeteria.

The opening hours are generally as follows:

Monday through Saturday and holidays when classes are held 11:00 a.m. – 3:00 p.m. (*Opening hours are subject to change.)

Each dormitory also has a shared kitchen for simple meal preparation.

9) Commitment to Maintaining the Dormitory Environment

If any of the facilities or equipment in the dormitory are damaged or destroyed, the individual or individuals responsible are as a rule required to cover the cost of repair or replacement.

We recommend that you buy liability insurance just in case.

10) Compensation for Damages

If any of the facilities or equipment in the dormitory are damaged or destroyed, the individual or individuals responsible are as a rule required to cover the cost of repair or replacement. We recommend that you buy liability insurance just in case.

11) Other Matters

- a) Possession of vehicles is prohibited.
- b) No pets are allowed in the dormitory.
- c) Use of products causing fire (incense, candles, fireworks, etc.) is strictly prohibited.
- d) Mining of cryptocurrency or similar activities is prohibited in the dormitory.
- e) Room changes are conducted several times a year.
