Thank you for applying to live in the student dormitories on the ICU campus.

Our student dormitories are "educational facilities" where students learn through "dialogue" to respect human rights and cultural differences, share responsibilities and tasks. Most students spend fulfilling years in these dormitories. We are delighted to welcome students to the dormitories this spring term.

On the other hand, since about three years ago, countermeasures against COVID-19 infection have been indispensable in a group living environment, and responsible behavior by each dorm resident and the understanding and cooperation of guarantors in managing the dormitory are indispensable.

We would like new dormitory residents and their guarantors to read the attached "To the Guarantors of Dormitory Students" very carefully. Students can only enter the dormitory when they accept the terms described here.

Please note that we may change our policy in the future if the Japanese government changes the status of COVID-19 under the laws concerning infectious diseases. In such cases, we will notify the guarantors through the dorm residents.

■ To the Guarantors of Dormitory Students

We have notified the dormitory students that it is a condition of staying in the dormitory that they must pledge the following items.

The consent of the guarantors is also required, so please read the following carefully. In addition, please also check the contents of the "Guidelines for the Prevention of the novel Coronavirus Infections in the On-campus Dormitories" issued by the university.

- 1) I understand and agree that the University is not responsible for any COVID-19 infections in the dormitory.
- 2) I understand and agree that the University cannot be involved in the treatment of coronavirus infections at all, except for the provision of facilities in a specified dormitory (hereafter referred to as "health observation dormitory"), and the University is not responsible for treatment.
- 3) If I am found to be infected with the COVID-19 and cannot receive medical treatment at my home, at a hospital, or hotel, and if I am allowed to remain at the health observation dormitory provided by the university, I understand and agree that I will be cared for by my guarantor or by the medical staff arranged by my guarantor or myself and to bear the costs of such arrangements and accommodation.
- 4) I understand and agree that the University has a limited number of rooms in the health observation dormitory, and if I cannot enter the health observation dormitory due to its being full with people with symptoms, those who are waiting for the results of their PCR tests, or have tested positive, or if I am in the health observation dormitory and I cannot arrange for my guarantor / medical staff to provide nursing care, I must move out of the dormitory.
- 5) If I have symptoms such as a fever, cold symptoms, loss of taste, or if I am in close contact with someone who tested positive (including suspected close contact), even if my PCR test results are negative, I will voluntarily quarantine for a certain period. I understand and agree that if I cannot enter the health observation dormitory, I must move outside of the dormitory promptly, and refrain from going out during that period.
- 6) If a cluster infection occurs in the dormitory, the floor or the entire dormitory itself may be closed at the direction of the health center or at the discretion of the university. In that

case, I will move out of the dormitory promptly. However, I understand and agree that I must stay at home to recuperate and refrain from going out during this time.

- 7) I fully understand the contents of the "Guideline for the Prevention of COVID-19 Infections in On-campus Dormitories" issued by the University, and agree to the contents of the guidelines, and I pledge to strictly comply with the guidelines, whether or not I have been vaccinated.
- 8) I pledge to share the contents of the above items 1) to 7) with my guarantor or guardian and obtain the consent of the guarantor or guardian.

Dormitory management and dormitory life are based on a relationship of trust and cooperation between the university, dormitory students, and guarantors. We, the university officials, will give maximum consideration to the safety and security of our students. We look forward to your continued understanding and cooperation.
